PROJECTS OVERVIEW


In 2019-2020 we were mainly engaged with The Freedom Project India. The team and the projects continue to grow, particularly the Sports for Life program and the women in the Safe House. We are especially excited to see the unfolding of the Heart of Baking program, which involves vocational training and income generation for the trafficking survivors that are living in our safe house. While we continued our partnership in Southeast Asia we did not receive or send funds throughout this period.

INDIA PROJECT OVERVIEW

KEY ACHIEVEMENTS

- Heart of Baking was established, and takes regular orders from the community, providing employment for women in our safe house
- 9 women and 1 minor rescued from exploitation
- 1 Bangladeshi woman repatriated
- 4 minors and 6 teenage boys rescued from forced labour
- 800-900 boys in our sports & mentoring program in 8 vulnerable communities
- 1,458 families supported during Covid-19 lockdown with dry ratios
- Approx. 130 house visits every month
- Underprivileged boys assisted with job placement and medical care though facilitation of vital documents



PROJECT OVERVIEW

In India, our vision is to work alongside the local community to prevent, rescue and restore those vulnerable to trafficking and slavery. This is achieved through community education; a Sports and Mentoring program for at-risk underprivileged boys; an investigations team who conduct raids and rescues; and a safe house for women and children who have been rescued. In 2019-2020, the TFPI team successfully launched Heart of Baking, providing training and

employment for the women in the safe house. The long-term goal of this project is to be replicated to other women needing reliable employment after being rescued from exploitation.

PROJECT GRANTS

The Freedom Project India received \$220,000 in the reporting period. This was used across the Sports Program, Safe House ministry and other anti-trafficking programs.

IMPACT STORY

A young woman trafficked from Bangladesh is repatriated to her family. This young woman was lured to Bangalore with false hopes of work and an opportunity to support her parents. She was sold to traffickers. Bangalore police received a call altered them to screams from a girl coming loudly from a particular house. When rescued by police she was put into a government home and here TFPI took action to get her back home. Our team were instrumental in procuring documents from the family that enabled the police to finally repatriate her to her family. This heart-breaking story is one of many girls enslaved in Indian brothels.


